Textual Information(1)	1. PAG Ecstasy (a promoter of the Company) pursuant to the terms of the unattested pledge agreement dated December 18, 2024 executed by and between PAG Ecstasy and the onshore security agent, created a first ranking pledge over 12,377,176 equity shares of the Company held by PAG Ecstasy, for the benefit of the lenders and agents. Additionally, PAG Ecstasy has, pursuant to the facilities agreement dated December 17, 2024 (Facility Agreement) executed by and between inter-alia PAG Ecstasy as the borrower and the lenders and agents, agreed to restrictions on its ability to dispose or create security with respect to all of the equity shares of the TC held by PAG Ecstasy, other than as permitted under the Facility Agreement (Encumbrance 1). 2. PAGAC Ecstasy II Pte. Ltd. (Parent of the Promoter) pursuant to the terms of the borrower share pledge agreement dated December 18, 2024 executed by and between the Parent of the promoter and the offshore security agent, created a pledge over all of the equity shares of PAG Ecstasy constituting 100% of the paid-up equity share capital of PAG Ecstasy held by the Parent, for the benefit of the lenders and agents. Additionally, the Parent has, by way of covenants under the Facility Agreement, agreed to restrictions on creating any security on or disposing of its assets (including the entire shareholding in PAG Ecstasy), other than as permitted under the Facility Agreement.
